The Icelandic Order of Freemasons Grand Lodge of Iceland

Our fraternity in Iceland began in 1913 when a “society of brothers”, Edda, was established in the capital, Reykjavik. In 1918, Edda became a lodge of instruction. One year later it became a fully warranted lodge.

Since 1919, twelve (12) warranted lodges and six (6) lodges of instruction have been formed. Icelandic Freemasonry was under the jurisdiction of The National Grand Lodge of Denmark until 1951 when the Danish Grand Master constituted the Grand Lodge of Iceland as a sovereign Order which now boasts a total membership in excess of 3,000.

Icelandic Freemasonry operates according to the Swedish Rite which is the dominant system in four (4) of the Nordic countries, and to some extent in Finland and Germany. It consists of eleven degrees, all of which are considered a part of Freemasonry. This system differs considerably from those used in English-speaking countries. There are, however, common characteristics which make a visit to an Icelandic lodge meeting interesting and most worthwhile.

Allow me to express my thanks to all of you for the honor you have bestowed on me by electing me Senior Warden of Forest City Lodge for 2008-2009. Our Lodge is considered throughout the 22nd District and the State of Ohio as one of the premier lodges in the Grand Lodge of Ohio.

Action Pest Control is owned by Bro. Marvin Smith, a previous Forest City Lodge Mason-of-the-Year. They have



FREEMASONRY AND THE AMERICAN REVOLUTION

The following was taken from ElectricScotland.com – “Scots and Freemasonry”

Go to the center of government in the State of Indiana, at the Indiana Statehouse located at the northwest corner of Washington and Capitol Streets. There, standing in the south lawn, is a larger-than-life figure of the Father of our Country, George Washington.

Is he wearing the uniform of the Commander-in-Chief of the Continental Army? No, he is in civilian dress. But, take a closer look. What is that under his coat? He is wearing an apron, a Masonic apron. And what is he wearing around his neck – a medal earned through the trials of military conflict? No, it is a compass with the sun at its center – the jewel of the office of Worshipful Master, the presiding officer in a lodge of Freemasons. Upon closer inspection there is seen a gavel in his right hand – the gavel which rests upon a pedestal is another symbol of the office of Worshipful Master.

Reach into your pocket and take out a **one dollar bill**. On the front you see the image of George Washington. There you see the obverse, and the reverse sides, of the Great Seal of the United States of America. On the right side of the bill you see the image that appears in the carpet of the Oval Office, and upon the lectern whenever Our President addresses the Nation – the Bald Eagle, our national symbol. In its right claw, it holds an olive branch with thirteen (13) leaves – representing our peaceful intentions. In its left claw are thirteen (13) arrows – representing our ability to wage war in our defense. Over the eagle’s breast we see a representation of our national banner with thirteen (13) stripes of red and white under a field of blue, while over the eagle’s head we see a constellation of thirteen (13) stars. In its beak we observe a scroll bearing the inscription, “E Pluribus Unum: or “Out of Many, One”.

Now look at the mysterious, and seldom displayed, image on the left side of the bill, which, reading from left to right, is actually the first thing that you see. A pyramid with thirteen (13) steps or tiers with the Roman numerals MDCCLXXVI chiseled into its base. The thirteen (13) steps or tiers refer to the original colonies or states, and the Roman numerals

read 1776, the year that the original colonies declared themselves to be free and independent states. **But wait**, what is that at the top of the pyramid, and what does the scroll at the bottom say?

The pyramid is surmounted with an image familiar to all Freemasons. It is called, “The All-Seeing Eye”, and it is a representation of the Deity, by whatever Name you choose to call **Him**, who is the Great Architect of the Universe.

More of Mr. Smith’s article will appear in future editions of Our bulletin.



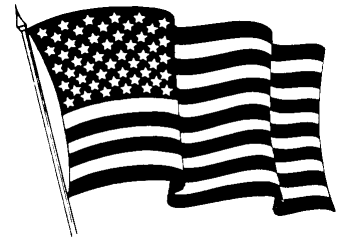
Thanks to Our Brethren and Friends

FROM OUR IMMEDIATE PAST MASTER



Many years ago when I was a neophyte Mason, and while attending a stated meeting, an officer from the C.C.B.L.A. (Cuyahoga County Blue Lodge Association) was introduced. I turned to the Brother next to me and asked him what was the C.C.B.L.A. He shrugged his shoulders.
